About the Juror:

DeWitt Cheng is a San Francisco-based art critic who writes for Art Ltd., Artillery, Sculpture, Huffington Post, Visual Art Source, East Bay Express and DeWittCheng.com. He has degrees in art history and studio art, and does freelance writing and curating.

Theme: The theme for the Second Annual Juried Exhibition is *Spaces and Places*. Artwork considered for this exhibition will depict either a real, invented or a psychological space or place. Creative interpretations encouraged. Work produced in the last three years is preferred.

Eligibility

Accomplished, mid-career and emerging artists living in the United States are encouraged to apply.

Media

Accepted media includes painting, drawing, printmaking, photography, sculpture, ceramics and mixed media. Sorry no video or performance art will be accepted at this time.

Size Limitation

Please include specific dimensions, weight and installation instructions per image. The Village Theatre Art Gallery reserves the right not to accept unusually large or cumbersome work.

Entry Fees

A non-refundable fee of \$30 is required. This fee covers up to 3 entries. Checks and credit cards accepted. Please make checks payable to the Town of Danville.

Jury and Notification

Jurying will be done from *digital images only*, thus image quality is critical. There is a limit of three images per artist. Entries must be at the Village Theatre Art Gallery on *or before 5:00pm, June 1, 2012*. Any entries received after that date or that are incomplete will not be considered. Entries will not be returned. **Artist will be notified of the results by e-mail no later than 5:00pm June 8th, 2012.**

Shipping and Delivery

All accepted entries must ship to be received by Village Theatre Art Gallery by **5:00pm, June 21, 2012**. Shipped work should arrive in a reusable container with return postage or prepaid shipping documents and correct return label. Be sure to indicate insurance value for shipping both ways. Hand-delivered artwork may be dropped off June 18 - 21, between the hours of 9:00am - 5:00pm.

Following the closing of the exhibition, artwork can be picked up between August 13- 15, 2012. Please arrange for a representative to pick up your work if you are unable. Artwork remaining at the Village Theatre Art Gallery past specified pick-up dates and times will be subject to a \$10 per day storage fee.

Liability

Artwork accepted for the exhibition will be insured by the Town of Danville from the time it is received and inspected by Gallery staff until artwork is returned to the artist or artist's agent. Delivery and pickup are the responsibility of the artist. During the exhibition, artwork will be insured against all physical loss or damage from any external cause. Insurance is limited to the wholesale value at the time of loss. If damage occurs and the piece can be repaired, liability will be limited to the cost of such repair.

Agreement

Submission of work constitutes an agreement to the conditions set forth and acceptance that the decisions of the juror are final. Village Theatre Art Gallery may photograph and reproduce accepted work for promotional purposes. Artists may not withdraw accepted entries before the close of the exhibition.

Sales

Accepted artwork can be available for sale at the Artist's discretion. All sales will be subject to the Town of Danville's Gallery Sales Policies (60% to the artist, 40% reserved by the Town). Specific information and agreement paperwork will be sent to accepted artists.

Entry Procedures

In addition to meeting the requirements above, all entries must include:

- Complete Entry Form: Additional forms or copies of the prospectus are available at www.villagetheatreartgallery.com. Please be sure to clearly complete all fields.
- Entry Fee of \$30.00 (Checks or Money Orders made out to Town of Danville)
- A CD with up to 3 images (one image per entered artwork, up to 3 works, or multiple view of few entries) in JPEG format. Images should be sized to 1280 pixels across the widest dimensions at 72 dpi and no larger than 1 MB each. Label files with your last name, first name, and image number (ex. LastFirst_1.jpg)

For online submissions, please complete the Entry Form information **in the body of the message** and attach your image files to the e-mail. Online entries will be held pending the arrival of a check. Payment must be received by entry deadline.

August 10: Exhibition Closes
August 13 - 15: Pick-up of artwork: Shipped artwork at the artists request and expense. The Art Gallery will charge a storage fee of \$10 per day after September 2 and is released from any liability due to property damage, etc.
