## Town of Danville Update: 4.27.20

### Extension of SIP Expected, Relaxation of Some Aspects

On Monday morning, the Contra Costa County Health Officer, in conjunction with the health officers of six other counties announced that an extension of the ongoing Shelter in Place Order to the end of May will be taking place this week, with some easing of current restrictions.

There is no further information available at this time. The county is expected to issue a statement later this week with the details of the extension and what changes the community will see in the current level of restrictions. The full message is [available here](#).
