

BUSINESSES ELIGIBLE/NOT ELIGIBLE FOR BUSINESS GRANT

In addition to the below eligibility list, businesses must:

- Be Independently Owned (not an independent contractor or home-based business)
- Have physical tenant space open to the public for goods and services in the Town of Danville
- Have a current business license and be in good standing with the Town of Danville
- Not a Corporation or Chain (independent franchise excluded)
